The prospective bidder must have completed, a single contract that is similar to the contract to be bid, and whose value, adjusted to current prices using Philippine Statistics Authority (PSA) consumer price indices, must be equal or more than the percentage stated in the Bid Data Sheet, particularly ITB Clause 5.4 within the last two (2) years. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post qualification of the lowest calculated bid shall be conducted.

Bidding is restricted to Filipino citizen/sole proprietorships, partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

All particulars relative Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s). Evaluation of Bids, Post-qualification and Award of Contract shall be governed by the pertinent provisions of RA 9184 and its Revised Implementing Rules and Regulation (RIRR).

Bidder/supplier must be able to log-in in the Philippine Electronic Procurement System (PhilGeps) wherein the name of the company will be reflected in the Documents Request List of the Bid Notice Abstract of the Procuring Entity.
